Instructor I in Teaching English as a Second Language (TESL)

The Department of Language and Literacy Education (LLED) in the Faculty of Education at the University of British Columbia invites applications for a tenure-track **Instructor I** position in **Teaching English as a Second Language (TESL)**. The appointment is expected to commence September 1, 2013.

The University of British Columbia is located in beautiful Vancouver, a multicultural, multilingual city ranked as one of the world's best places to live. The university is recognized internationally as a leading research institution and, recently, was ranked as #1 in Canada in the social sciences and humanities by the Higher Education Strategy Associates. The Faculty of Education shares this commitment to research excellence and provides a comprehensive set of programmatic offerings at the baccalaureate, magisterial and doctoral levels. Academic units include the Department of Language and Literacy Education, the Department of Educational Studies, the Department of Educational and Counselling Psychology, and Special Education, the Department of Curriculum and Pedagogy, and the School of Kinesiology. The Faculty is a leader in Indigenous Education and offers additional cross-Faculty initiatives in early childhood education, educational technology and interdisciplinary studies. The Department of Language and Literacy Education (<http://lled.educ.ubc.ca>) has a major commitment both to undergraduate (teacher education) and graduate programs in the Faculty of Education. Responsive to Canada's multicultural, multilingual context, the Department engages in research, provides instruction and collaborates with educational communities at the local, national, and international levels to advance the study of language in learning, and the teaching and learning of language, literacy, and literature in their broadest frames of reference. The position advertised pertains to our local engagements with Teaching English as a Second Language and efforts to support English language learners in schools and other institutions.

Applicants for the Instructor position will have an earned doctoral degree in TESL, applied linguistics, second language education, or equivalent; experience teaching in K-12 schools, ideally with some of that experience in Canadian schools; demonstrated effectiveness in teaching English language learners in both language courses and in courses that integrate language and content instruction (with attention to language across the curriculum); and demonstrated experience coordinating, administering, and teaching in postsecondary programs connected with TESL.

Preference will therefore be given to applicants with the following qualifications: (a) familiarity with the BC educational context; (b) possession of a K-12 teaching certificate (ideally from Canada); (c) experience in teaching K-12 ESL and/or language/content integration in mainstream classes; (d) experience and interest in inquiry-based teaching and facilitating collaborative curriculum development; (e) a commitment to multicultural and anti-racist education, (f) a commitment to instruction building upon students' native languages and cultures, and (g) recent experience in teacher education. Experience with other languages, literacies, and cultures in Canada and internationally is an asset. Successful applicants will be expected to teach in Faculty and Department undergraduate programs primarily, coordinate multiple sections of courses, assist with practicum supervision, contribute to program development and scholarship in TESL and related areas, provide liaison to the local community, and provide our M.Ed. students with academic support, as needed. Although the position is designed primarily for K-12 teacher education contexts, knowledge of effective education for postsecondary English language learners will also be an asset in order to offer professional leadership and teaching in
